

Terms and conditions of the “Global Protection 2012 Beta Competition” organized by Panda Security

AIM: Panda Security, with registered offices at Gran Vía Don Diego de Haro, 4, 48001 Bilbao, Spain (herein Panda) is organizing the “Global Protection 2012 Beta Competition” available through:

The Panda Global Protection 2012 Beta Competition is a contest in which participants can report bugs and comments to Panda Security regarding their experience with the Beta version of Panda Global Protection 2012 under the conditions stated herein. Both the participants and the bugs reported to Panda Security must comply with the requirements established in the present document.

GEOGRAPHIC LIMITS: The Competition is open to users worldwide.

PERIOD: The Competition shall be open from Monday, February 28, 2011 at 10.00h (GMT + 1) to Monday, May 30, 2011 at 10.00h (GMT + 1). Panda reserves the right to suspend, postpone or cancel the Competition at any time prior to the selection of winners, provided there is justification for doing so.

CONDITIONS: The Competition is open to all participants aged 18 and over. The Competition is not open to Panda Security employees, their relatives or former Panda Security employees (including Country Partners). Both the participants and the bugs reported to Panda Security must comply with the requirements established in the present document.

The competition consists in the following phases:

- **Participation Phase:** From February 28th, 2011 to May 30th, 2011 (both inclusive). To take part in the competition, participants must download the beta version of Panda Global Protection 2012 and send at least ONE comment, bug or remark on the product to our Beta Department:

- **Evaluation Phase:** Open from the end of the Participation Phase to July 15th, 2011. During this period of time, an Evaluation Committee will study the bugs reported (quantity and quality) during the Participation Phase in order to determine the competition winners, by applying the evaluation criteria specified in these Terms and Conditions.
- **Communication and publication of winners' names:** Panda will notify by e-mail the winners within 20 working days after the end of the Evaluation Phase. Panda will inform the winners at the same e-mail address that the participants used to report bugs or remarks on the product.
- **Prize delivery phase:** Contacted winners must reply to Panda's notification by e-mail within 30 calendar days. Panda Security will then make the prize available through Amazon for the winner to be able to use it immediately. 30 calendar days after the notification, the prize will be canceled if Panda Security does not receive a response from the winner by e-mail.

To take part in the competition, participants must download the beta version of Panda Global Protection 2012 and send at least ONE comment, bug or remark on the product to our Beta Department:

Panda Security may request written proof of fulfillment of the requirements specified in this section by the participant(s), prior to delivering the prize.

EVALUATION CRITERIA: The bugs reported by participants during the Participation Phase must be related to the functions, features and characteristics of Panda Global Protection 2012 Beta version.

The Evaluation Committee will be made up of Panda workers, expert in Panda Global Protection 2012. The Evaluation Committee shall only evaluate the bugs (quantity and quality) reported during the Participation Phase.

The Committee will take into consideration the data submitted by beta testers in order to evaluate their technical skills in testing the product and detecting bugs. Both bug reports and errors reported in the product texts will be considered.

The Evaluation Committee will select the 5 beta testers that prove to have the best skills at analyzing our product (quantity and quality of feedback received) and have most helped Panda Security to improve it.

PRIZES: The 5 winners will each win an Amazon gift card valued at US\$200 or 200€ depending on the currency of the country of each winner.

Panda reserves the right to substitute the prizes specified for other prizes within the same range, with an equal or greater value than those indicated in the present Terms and Conditions.

Panda reserves the right to revoke any of the prizes should it detect irregularities.
